Discussion

*Comment:*

The importance of networking and regular contacts between national parliaments as well as between national parliaments and the European Parliament is stressed in the Lisbon Treaty. The new Treaty provisions open the field for debate on coordination of EU interparliamentary activities as well as the future role of COSAC.

The EUSC Presidency has suggested that the focus of the discussion, with reference to the area of freedom, security and justice, at this stage ought to be on ensuring the involvement of parliaments in the drafting of regulations on parliamentary participation regarding Europol and Eurojust, as well as discussions on the format of interparliamentary activities in this field.

Furthermore, an initial discussion to examine the question of the future parliamentary scrutiny of European security and defence policy is needed.

Continued debate on future expectations regarding interparliamentary cooperation in the light of the Lisbon Treaty is anticipated. This includes the format and working methods of the Conference of Speakers of EU Parliaments.

On 12 December, initial issues of priority and format were identified in relation to the continued process for work in this field. The Swedish EUSC Presidency is submitting a progress report on the IPEX forum debate on interparliamentary cooperation in the era of the Lisbon Treaty for

consideration. The report includes a proposed update of the Guidelines providing rules and procedures for the Conference of Speakers of EU Parliaments. Also, a proposal for a common approach to coordination in the planning of interparliamentary meetings has been included (the Hague Guidelines annex). The management of this coordination by an extended “trio-plus” formation as suggested at the meeting of Secretaries-General on 8 March is recommended.
